

Spring Season 2007 SDABL Managers Agreement

I, Print Manager Name as the designated and culpable representative for Print Team Name/League Baseball Team, am the responsible party for all team matters relating to the SDABL. I acknowledge that I have read and understand the current SDABL Rules and Guidelines, Player Contract and Waiver, and said terms within these documents and accept the terms and conditions set forth within in this Agreement.

I understand that is extremely important that I am fully aware of the following Team Commitments and their requirements for completion:

League Fees:

League Fees for the above listed team are to be paid in full no later than **February 15, 2007**. Failure to do so will put your team at risk of exclusion from the Spring Season schedule.

Online Team Registration:

Your Online Team Registration (registering your team name in the appropriate league) is to be completed no later than **February 19, 2007**. Failure to do so will result in your team's exclusion from the Spring Season.

Player Registration:

You are required to have no less than 9 players Registered by **February 27, 2007**. You are to maintain a minimum of 12 Registered and Eligible Players during the course of the Spring Season, and if eligible, for all subsequent playoff games. All Player Registrations during the course of the Season are to be completed in a proper and timely manner as described in the current SDABL Rules and Guidelines. Failure to do so will put your player's eligibility at risk, as well as your team will be subject to forfeit and possible removal from the remainder of the Spring Season schedule. Both your commissioner and opposing team managers have the right to scrutinize your rosters for compliance.

Forfeits, Fines and Penalties:

All Forfeit Fees, Fines and Penalties are to be paid in full no later than the Close Of Business of the following **Wednesday** of the week immediately following the assessed forfeit. Failure to do so may/will result in your team's forfeit of the next weekend's game.

By this agreement I acknowledge there is no grace period or recourse except to complete these requirements within the given periods as defined above for any and all of the terms listed.

Furthermore, my signature affirms my commitment to the above obligations, and I understand all potential League recourse in effort to remedy any and all issues, including game forfeit(s), fines, manager, player and team suspensions or ineligibility.

My Financial Responsibility:

In the event that for any reason I relinquish, or I am removed, as the Team Manager I will **remain liable** as the Manager of Record for any outstanding monies owed the League due to fines or team fee balance during the course of my tenure.

I further understand that any such monies owed will “follow” me even as a player and I will be required to pay in full before being allowed to participate again in the SDABL. I accept that the impetus is on me to manage the above terms and conditions.

Upon execution of this Agreement with my signature below, I agree to the Terms and Conditions set forth herein and understand and acknowledge all possible League recourse should I fail to meet these obligations and remedies.
